Subject: **Resolution of the Annual General Meeting on payment of dividend for 2021**

The Management Board of IPOPEMA Securities S.A. of Warsaw (the “**Company**”) hereby reports that on 25 May 2022 the Annual General Meeting of the Company passed a resolution on the allocation of profit for 2021, according to which the entire net profit for the year ending on 31 December 2021, amounting to PLN 9,454,028.75 shall be allocated for payment of dividend to the Company's shareholders.

The amount of dividend per share will be rounded down to full grosz, and the difference between the amount of net profit for 2021 specified above and the amount of dividend payable to the shareholders after rounding will be posted to the Company's statutory reserve funds. The amount of dividend per share determined in this manner, calculated for the current number of outstanding Company shares (29,937,836), is PLN 0.31 (thirty one grosz).

The dividend record date is 3 June 2022, and the dividend payment date is 10 June 2022.
